ORDER ESTABLISHING THREE SEPARATE AND DISTINCT  
GEOGRAPHIC AREAS WITHIN THE NORTHERN DISTRICT OF FLORIDA  
FOR THE CALLING OF GRAND JURORS

WHEREAS this district has now established a full time court facility in Gainesville, Florida, and

WHEREAS it is deemed to be in the best interest of public, as well as promote both judicial and fiscal economy, that a separate place for convening and conducting grand jury proceedings be established in the Gainesville Division

THEREFORE, in accordance with the Jury Selection and Service Act Amendments made by the Judiciary's Housekeeping Bill, Article XIII of the Plan of the United States District Court for Northern District of Florida, All Divisions, for the Random Selection of Grand and Petit Jurors ("Plan") is hereby amended, revised and adopted as follows:

XIII GRAND JURIES

Three separate and distinct geographic areas of this district are hereby established for the calling of grand jurors, to wit:

(a) Unless otherwise specifically ordered by the supervising judge, as defined in Paragraph III, a grand jury for the Pensacola and Panama City Divisions shall sit in Pensacola. An equal number of names shall be drawn at random from the qualified jury wheels of each of these two divisions only, and those so drawn shall constitute juries for these two divisions only; and


(b) Unless otherwise specifically ordered by the supervising judge, as defined in paragraph III, a grand jury for the Tallahassee Division shall sit in Tallahassee. Names shall be drawn at random from the qualified jury wheel of this division only, and those so drawn shall constitute the grand jury for this division only; and

(c) Unless otherwise specifically ordered by the supervising judge, as defined in paragraph III, a grand jury for the Gainesville Division shall sit in Gainesville. Names shall be drawn at random from the qualified jury wheel of this division only, and those so drawn shall constitute the grand jury for this division only.


