## **ORDER DEFINING CASE REFERRALS**

In order to effect an equitable allocation of civil and criminal cases among the magistrate judges of this district, it is hereby ORDERED that the following referral system be implemented by the Clerk, effective September 1, 2007:

#### PENSACOLA DIVISION

Prisoner (510) civil cases shall be referred to Magistrate Judge Miles Davis
Prisoner (530) civil cases shall be referred to Magistrate Judge Elizabeth M.
Timothy.

Prisoner (555) and Social Security (861,862,863,864,865) civil cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis.

50% to Magistrate Judge Elizabeth M. Timothy.

All other civil cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis.

50% to Magistrate Judge Elizabeth M. Timothy.

Criminal cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis.

50% to Magistrate Judge Elizabeth M. Timothy.

#### PANAMA CITY DIVISION

Prisoner (510) civil cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis

50% to Magistrate Judge Allan Kornblum

Prisoner (530) cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis

25% to Magistrate Judge Allan Kornblum

25% to Magistrate Judge Elizabeth M. Timothy

Prisoner (555) civil cases shall be referred on a random basis:

50% to Magistrate Judge Miles Davis

50% to Magistrate Judge Elizabeth M. Timothy

Social Security (861, 862, 863, 864, 865) civil cases shall be referred on a random basis:

20% to Chief Magistrate Judge William C. Sherrill, Jr.

40% to Magistrate Judge Miles Davis.

40% to Magistrate Judge Elizabeth M. Timothy.

Other civil cases shall be referred on a random basis:

37.5% to Magistrate Judge Miles Davis.

25% to Magistrate Judge Allan Kornblum.

37.5% to Magistrate Judge Elizabeth M. Timothy.

Criminal cases shall be referred to Magistrate Judge Larry A. Bodiford.

#### **GAINESVILLE DIVISION**

Social Security (861,862,863,864,865) civil cases shall be referred on a random basis:

25% to Chief Magistrate Judge William C. Sherrill Jr.

75% to Magistrate Judge Allan Kornblum

All other civil cases and all criminal cases shall be referred to Magistrate Judge Allan Kornblum.

### TALLAHASSEE DIVISION

Prisoner (510) civil cases shall be referred on a random basis:

60% to Chief Magistrate Judge William C. Sherrill, Jr.

40% to Magistrate Judge Allan Kornblum.

Prisoner (530) civil cases, 28 U.S.C. § 2254 cases only, shall be referred on a random basis:

40% to Chief Magistrate Judge William C. Sherrill, Jr.

20% to Magistrate Judge Miles Davis.

20% to Magistrate Judge Allan Kornblum.

20% to Magistrate Judge Elizabeth M. Timothy.

Prisoner (555) civil cases shall be referred on a random basis:

60% to Chief Magistrate Judge William C. Sherrill, Jr.

40% to Magistrate Judge Allan Kornblum.

All other civil cases and all criminal cases shall be referred to Chief Magistrate

Judge William C. Sherrill, Jr.
