- Mar. 30, 2017: Deadline for plaintiffs to serve record authorizations.
- Mar. 30, 2017: Deadline for Defendant Fact Sheets.
- Sept. 8, 2017: Substantial completion of defendants' document production.
- Sept. 22, 2017: Deadline to complete depositions of plaintiffs, their family members, and their treating physicians. The parties agree

- Jan. 19, 2018: Defendants' expert report(s).
- Feb. 5, 2018: Rebuttal expert report(s).
- Feb. 5, 2018:Parties to provide three potential deposition dates for each
of their experts.
- Mar. 2, 2018: Deadline to complete depositions of experts.
- Mar. 23, 2018: *Daubert*/dispositive motions.
- Apr. 6, 2018: Oppositions to *Daubert*/dispositive motions.
- Apr. 16, 2018: Replies, if any, limited to new matters not addressed in the original supporting memorandum.
- Apr. 20, 2018: Target date for *Daubert* hearing.
- Apr. 27, 2018: Selection of case for trial based on process to be determined, and additional Scheduling Order governing remaining pretrial events (e.g., deadline to exchange trial witness, trial exhibits, etc.).
- May 17, 2018: Motions in limine for trial case.

- May 24, 2018: Oppositions to motions in limine.
- May. 31, 2018: Replies, if any, limited to new matters not addressed in the original supporting memorandum.
- June 2018: Pretrial conference and first trial.

The Court enters the following schedule for additional cases in this MDL:

Plaintiff Profile Forms are due within 45 days of the date of this Order for existing cases. Plaintiff Profile Forms are due within 30 days of filing for any newly-filed cases.

For any additional cases for which the Court orders a full work up, Plaintiff Fact Sheets with authorizations are due within 45 days of the date of such Order, and Defense Fact Sheets are due within 45 days after the receipt of Plaintiff's Fact Sheet.
